The interested prospective eligible bidders can obtain a complete set of Bidding documents from office of the Executive Engineer Communication & Works Department GB, B&R Division at Garelth Hunza on submission of a written application and production of following original documents personally for the specific work duly deposited the cost of bidding documents through Treasury Challan as mentioned above against each work, immediately after the advertisement published in the newspapers & GB-PPRA Website:
 - PEC valid registration 2025 and Code.
 - Renewal Fee Current Financial Year 2024-25.
 - c. CNIC of the prospective bidder.
 - d. Bid security in shape of CDR from scheduled bank of Pakistan show in original.
 - e. No sick scheme and no litigation certificates.
- 3. All bids must be accompanied by a bid security as indicated above against each work and in case of rates quoted below 10% of estimated cost shall be required to provide alongwith bid an additional performance guarantee of 50% of the differential amount (between estimated cost & bid cost) in shape of CDR/Bank Guarantee from any Schedule Bank of Pakistan clearly mentioning the name of firm in favour of Executive Engineer Communication & Works Department GB, B&R Division at Garelth Hunza. The sealed bids must be delivered on due date & time as mentioned above, which will be opened on the same day in the office of Executive Engineer Communication & Works Department GB, B&R Division at Garelth Hunza in presence of bidders who choose to attend at the same address.

OTHER TERMS & CONDITIONS:

- i. The subletting of contract, if any, shall be filled in the given format in the bidding documents and same shall be made part of CA, otherwise subletting shall not be allowed.
- ii. The original contractor come himself for collection of tender/bidding documents. In case of Joint Venture, only the lead and Associate partner mentioned in partnership deed is allowed. Authorization/attorney will be entertained subject to provision of Judicial stamp paper for specific work duly signed by owner and attested by Magistrate 1st class.
- iii. All bid securities/CDRs will be retained till acceptance of tender/bid and will be refunded after acceptance of tenders/bids.
- iv. The information provided by the bidders if found ambiguous will be verified and in case of fake one, the tender of firm will be cancelled and face immediate/appropriate penal action as per Rules/Laws.
- v. Late receipt of bids from the **SCHEDULED TIME** will not be accepted/entertained.
- vi. GB C&WD authorities reserves the right to reject any or all the bids or proposals at any time prior to acceptance of a bid or proposal under GB-PPRA Rules.
- vii. In case of any public/local holiday or surprise engagement of the undersigned the same will be opened on next working day.
