3. Sealed tender document must reach at office of the undersigned on or before the dates and time mentioned above. Tender documents will be opened on the same day as schedule given above in presence of Contractor or authorized representative.

GENERAL TERMS AND CONDITIONS.

- i. Earnest money as mentioned above must be attached with the tender documents in the form of demand draft/pay order in the name of Divisional Forest Officer Parks & Wildlife /DDO Gilgit from any schedule bank.
- ii. Tenders with incomplete supporting documents shall not be accepted and furnishing incorrect information shall be liable to legal action.
- iii. An affidavit on stamp paper of Rs. 100/- must be accompanied with the tender documents to the effect that the bidder has never been blacklisted by any documents/Semi-Government Organization/PPRA.
- iv. The firm/contractor winning the bid shall be bond to supply the items to Rehabilitation Center Naltar till 30th June, 2027.
- v. The Tender shall be consider category wise and firm shall bound to supply/provide goods/services at rates quoted in tender during the financial year 2026-2027.
- vi. Firms quoting inappropriate rates with respect to market rates to bring itself/himself lower shall not be considered.
- vii. The Firm/supplier /Contractor will bond to supply food/diet (Fresh/certified by veterinary meat i-e Mutton. Beef and chicken) as per schedule fixed by the competent authority for Snow leopard at Naltar.
- viii. The contractor must have relevant experience to participate in the tender.
