The prospective eligible bidders who have submitted fee in Treasury account C02706-others vide Works Secretariat Notification No. SW-7(104)/2022-23/4977 dated 24-10-2022 and shall show challan in original before date of closing of bid alongwith written application properly diary and dispatch numbered may obtained, personally or through an authorized representative with duly attested power of attorney, a set of bidding documents immediately after the advertisement published in the News Paper etc. The application shall be mandatorily accompanied by the following documents: -
1. PEC valid registration for CFY.
  2. PEC relevant Category and Code.
  3. CNIC of the prospective bidders
  4. Latest profile of the contractor from PEC Website.
  5. NOC for "No Sick Project" from Works Department/Affidavit by the contractor/firm.
  6. Bid Security as specified in shape of CDR/TDR from any schedule bank
  7. In case of JV, JV agreement on proper format duly signed by all partners of JV clearly mentioning share of each partner and lead partner duly attested by Magistrate 1<sup>st</sup> Class.
  8. On single bid by one bidder either in form of JV or single bidder.
  9. The Call deposits (CDR) provided by the bidders alongwith bid will be verified from the relevant bank prior to acceptance of the bid by the concerned authority.
  10. The bid prepared for above work in accordance with the instructions contained in the bidding documents. Bid evaluation criteria must reach in the office of the Superintending Engineer C&WD GB Circle Office Konodass Gilgit (President of Bid Evaluation Committee). Envelop marked "Technical Bid alongwith bid security" will be opened on the same date by the Committee already constituted and preliminary examination of technical bids will be carried out of substantial responsiveness of technical bid.
  11. The **pre bid meeting** will be held in the office of the Superintending Engineer C&WD GB Gilgit Konodass Gilgit on **09-07-2025 at 12:00 PM.**
  12. No bid shall be accepted beyond closing time as mentioned against each work.
  13. In case of any deviation conflict in bidding procedure the provision of PEC and PPRA rule 2004 shall prevail.
  14. All tender shall be called according to GB PPRA rules and latest PEC guidelines issued by Secretary Works C&WD GB vide Notification No Sec-SO-D-9(28)/2024-25/2001 dated 29<sup>th</sup> May, 2025, as mentioned in NITs / bidding documents.
