

1. Valid license of Pakistan Engineering council in relevant category & field of specializations.
2. A complete set of bidding Documents containing detailed terms and conditions may be purchased by an interested eligible bidder /authorized representative having power of Attorney on submission of a written application on original letter pad, on production of bid security (2%) and original CNIC, from the office of the undersigned located at LG&RD Complex Jutial Gilgit upon payment of a nonrefundable fee as indicated above till 30th May 2025.
3. In accordance with GBPPRA Rule 28; Bid Security as indicated is required in shape of CDR, Bank Draft or Bank Guarantee in favor of undersigned from any schedule bank, dully mentioned the name & title of the firm.
4. Rates quoted below 10% of Tender Cost must be associated with the full differential amount as additional performance security in the shape of CDR from any schedule bank of Pakistan in the name of Executive Engineer LG&RD Tech wing Gilgit along with financial bid/NIT which will be verified from the relevant bank otherwise the bid will be rejected, treated as defective/non responsive.
5. The submission of tender by constructors implies that he is fully conversant with the site and scope of work and terms and conditions as laid down in the tender documents.
6. Conditional/incomplete tenders will be summarily rejected.
7. No bidding document will be issued through post, telegraph or E-Mail and on day of opening. The undersigned in accordance with GBPPRA Rule-36 of 2022 may reject all bids or proposals any time prior to the acceptance of a bid or proposal.
