Gilgit-Baltistan Police Department invites sealed bids based on the **PPRA Rule-2022**, from well reputed and financially sound firms having previous experience as well as registered with Income Tax and Sales Tax Departments (where applicable), for the supply of printing materials/items for Central Police Office Gilgit-Baltistan to meet the requirements of Khidmat Markez of 10 districts in GB for the financial year **2024-25**.

Terms and condition:-

1. Sealed bids may be submitted to the undersigned before the closing date/time (as mentioned above) which will be opened by the committee in the presence of bidders/suppliers or their authorized representatives at Central Police Office KIU Road Konodas, Gilgit.
2. Separate envelopes procedure as per clause 36 (b) of PPRA Rules-2004 containing Technical and Financial proposal must be submitted before the closing date/time and only those bidders will be qualified for financial bidding who fulfill technical terms and conditions (as per evaluation criteria)
3. The bidder/supplier may offer only that category of tender which bidder/supplier has a complete set up (own Shop/store, workshop, press etc).
4. The contractor/supplier will be bound to supply demanded items/services at CPO Gilgit on the same rates during the financial year 2024-25.
5. Tender of each category be offered mentioning name of the category in bold manners on sealed envelope.
4. Rates quoted would be considered only if the same are in Pak. Rupee and inclusive of all taxes/duties. The bidder shall submit bid security @3% of allocated budget with their "Technical Proposal" in the shape of Pay Order/Bank Draft of any Scheduled Bank in favour of AIG Logistics GB Police Gilgit. Bids without Earnest Money will be rejected straightaway.
6. The bids/proposals of only registered firms/dealers/suppliers/contractors will be entertained.
7. All kind of taxes (where applicable) will be inclusive in the bid price and borne by the firms/dealers/suppliers/contractors.
8. Conditions ambiguous and incomplete bids will not be accepted.
9. The competent authority reserves the rights to accept or reject any one or all the tenders.
10. The rates of items offered by the contractor must be filled computerized i.e manually filled rates will not be accepted.
11. The interested firms are required to collect the bidding documents containing terms and conditions, list of the item etc, from the office of the AIG Logistics CPO Gilgit-Baltistan on any working day during office hours on written request on the firm's letter head pad on payment of Rs.2000/- (Tender Fee). In case of public holiday due to any reason the date of receiving and opening of the tenders will be next working day.
