TENDER NOTICE

- Sealed tenders are invited from reputed and registered firms/contractors for the provision of laboratory services for the Pathology Laboratory of Gilgit Cardiac Hospital for the financial year 2025-26, as per the tender documents.
- 2. Interested firms must deposit earnest money equivalent to 5% of the bid amount in the form of a Call Deposit Receipt (CDR) from any scheduled bank, in favor of "Medical Superintendent Gligit Cardiac Hospital". The CDR should be attached with the technical bid, and bids without the CDR will not be considered eligible for evaluation.
- 3. Sealed tenders must reach the office of the Medical Superintendent, Gilgit Cardiac Hospital, on or before August 21st, 2025, at 11:00 AM. Tenders will be opened on the same day at 11:30 AM in the presence of the bidders or their authorized representatives. Late submissions will not be accepted. If bid closing/Opening date fall on local/national Holiday, the date of bid closing/Opening shall be the next working day on the same time and Venue.
- Conditional or incomplete Vendor/Firm will be rejected.
- 5. Only firms registered with a National Quality Assurance Board or Agency are eligible to participate in this tender. A copy of the valid registration certificate must be attached to the tender document. Failure to provide the registration certificate will result in the rejection of the Vendor/Firm. The firm/vendor should have well reputed & functional lab in Gilgit city.
- 6. MS Gilgit Cardiac Hospital reserves the right to terminate this contract with immediate effect if the pathology lab reports consistently fail to meet the standard requirements of pathology or if the reports are found to be substandard/erroneous.
- 7. MS Gilgit Cardiac Hospital reserves the right to terminate this contract at any time if the Hospital Lab becomes operational and is ready to provide the services outlined in this agreement.
- 8. Bidders can obtain a complete set of bidding documents, including evaluation criteria, from the office of MS Gilgit Cardiac Hospital, located at Near Lalik Jan Stadium, Public Chowk, Jutial, Gilgit. A non-refundable fee of Rs. 1,000/- must be submitted to obtain the documents, and the original receipt must be presented.
- 9. MS Gilgit Cardiac Hospital reserves the right to accept or reject any or all bids in accordance with the Public Procurement Regulatory Authority (PPRA) Rules. Furthermore, only computerized rates will be accepted, handwritten rates will not be considered.
- 10. The successful Vendor/Firm shall be responsible for providing and maintaining the lab Equipment, Lab Machinery, Lab Reagents, lab Electricity bills and 2 to 3 Qualified Human resources. The hospital will not be liable for any costs or expenses related to these items.
- 11. If any lab tests are not listed in the tender document but are required in the future, the vendor/Firm will be responsible for supplying them at discounted rates (50% Less than market rate). The vendor/Firm will provide these additional tests at a mutually agreed-upon rate, ensuring that the hospital receives the same discounted pricing as specified in the agreement.

12. The laboratory services provided by the vendor/Firm under this agreement shall be exclusively for the patients of Gilgit Cardiac Hospital and shall not be extended to private patients
