**TERMS AND CONDITIONS:-**

- a. Registration with Pakistan Engineering Council (PEC) in relevant Category duly renewed for the year 2024-2025. **(MANDATORY)**.
- b. Receipt of renewal fee with Water & Power Department Gilgit-Baltistan for the year 2024-2025. **(MANDATORY)**.
- c. Specialization Codes CE-04(iv) (Water Retaining Structures), CE-04(vii)(Flood Control Systems Only), and CE-11(i) (General Engineering works). **(MANDATORY)**
- d. Experience in similar nature of work(s) executed in the last five years, with completion certificate duly countersigned by the Executive Engineer. At least One Similar nature of work having minimum cost 80% of the estimated cost of the work(s). **(MANDATORY)**
- e. At least 350 Rft. plumb concrete retaining wall executed, with completion certificate duly countersigned by the Executive Engineer. **(MANDATORY)**.
- f. No Sick/ Litigation Certificate and No Black listing certificate duly issued by Water & Power Secretariat and Affidavit of No delayed project in hand duly issued by 1<sup>st</sup> Class Magistrate. **(MANDATORY)**.
- g. Earnest money (04%) shall be provided with bidding documents. **(MANDATORY)**.
- h. If the bidder quoting rates below 10% of Engineer's estimated cost shall be required to provide along with his bid an additional performance guarantee of 50% of the differential amount (between estimated cost & bid cost) in the shape of CDR from any schedule bank of Pakistan. **(MANDATORY)**
- i. Each Contractor is eligible to be participate in the bidding process of only one of the works mentioned above.
- j. Conditional tender will not be accepted.
- k. No tender will be sold on the date of opening of tender.
- l. Bid received after due date & time should not be considered.
- m. Bidding document can be collected from Office of the Executive Engineer Civil Engineering Division W&P Department Gilgit-Ghizar on cash payment (non-refundable) during office hours by submitting written application along with mandatory/ requisite documents.
- n. The information provided by the bidders if found ambiguous will be verified and in case of fake one, the tender of firm will be cancelled and face immediate/appropriate penal action as per Rules/Laws.
- o. In Case of Gazette holiday/ Local Holiday/ Surprise engagement, tender shall be opened on next working day without further intimation.
- p. The Contractor debarred by any Region/ Division and notified by Water & Power Secretariat shall not be eligible to participate in the bidding process.
- q. Time allowed for completion of the works is **60 Days Only**.
- r. GB-PPRA rules will be applicable to the entire procurement process in true letter and spirit.
