



Subject: **INVITATION FOR BIDS**

1. Gilgit-Baltistan Communication & Works Department (GB C&WD), Gilgit Region, invites Single Stage Two Envelope (SSTE) bidding procedure to well reputed and experienced contractors/firms/JV who can prove their eligibility, qualification and competence for execution of the works:

2. Bidding documents shall be submitted to Executive Engineer B&R Nagar during office hours documents received after deadline will return unopened to the prospective bidders. The Single Stage Two Envelope bidding procedure will be processed as GB C&WD under a board of Engineers already constituted by the Secretary GBC&WD.

3. **TERMS AND CONDITIONS**

- i. A valid PEC registration certificate for the year 2024 -25 in the relevant category and code (Category C-5, and above) with specialization code is required.
- ii. Departmental No Litigation/No Sick scheme certificate on the behalf of office of the Secretary Works C&WD in prescribed format for year 2024-25.
- iii. Renewal receipt in Works Department GB is required for the financial year 2024-25.
- iv. Copy of National Identity card (owner of the firm).
- v. The firm/contractors should attach affidavit stating that no fake/tempered or bogus information contain their broacher submitted for Single Stage Two Envelope bidding procedure otherwise if found fake/tempered or bogus the firm/JVs will be blacklisted or ban from future procurement process under rule and policy.
- vi. Contractors/Firms having more than 03 works in hand in Communication & Works Department shall be discouraged.
- vii. The firms/JVs shall not be qualified if already awarded work is delayed or sick without any justification/reason. A certificate from the concern Executive Engineer is required to be attached in this regard.
- viii. All interested firms/JVs are required to submit the mandatory details and provide documentary evidence of their technical and financial capabilities with relevant experience in a brochure duly sign, stamp and page numbered by the authorized representative of the firm/JVs (as the case may be).
- ix. Detailed list of works already executed or in hand by the firm duly attested by the Executive Engineer of concerned Division.
- x. Applications of those contractors whose names are included in the list of sick projects are their name forwarded to PEC for cancellation of their license will not be considered for evaluation process.
- xi. For the ease of evaluation process and restricting uninterested bidders from participation the employer in line with tender policy and PPRA rules states that it is mandatory for prospective bidders to bring following mandatory documents at the time of issuance of bid documents.
 - i. Original PEC license of Firm/JVs fulfilling aforementioned conditions at Para 2.
 - ii. At least 2 Nos of work of similar Nature & Complexity amounting to Rs. 9.224 million with start orders and completion certificates
 - iii. Renewal Fee receipt with C&WD for the year 2024-25.
 - iv. Only project specific power of attorney on the behalf of CEO/MD/Director of firm is accepted if provided on judicial stamp paper duly sign and stamp by 1st Class Magistrate.
 - v. The firm/JVs not having any of the above enumerated documents would not be able to participate in bidding process.
- xii. Application along with complete broacher showing information i/c name and address and contact No. etc.
- xiii. Bank transaction statement, line credit for the last 6 months from related to your account (Schedule bank of Pakistan) must be attached your broacher.
- xiv. Conditional Application will not be considered for Evaluation process.
- xv. The Bidder quoted rates below 10% of T/S Estimate shall be required to provide along with his bidan additional performance guarantee of 50% differential amount (between T/S and Bid) in shape of CDR from any schedule bank of Pakistan. In case of failure to produce the required differential amount of bid by the bidder along with his bid documents, the bid shall be rejected and original CDR amount shall be forfeited.
- xvi. The CDR of all unsuccessful/not participated bidders will be released after expiry of bid validity or formal approval of tender which is earlier.
- xvii. The procuring agency reserves the right to reject all bids or proposals at any time before accepting a bid or proposal, in accordance with Rule 36 of GBPPRA Rules as amended vide SRO dated 9th September, 2022.
- xviii. If in any case the local holiday will be observed on the date of opening of Bid then next working day will the opening day of bid with same time and conditions.
