- a. Registration with Pakistan Engineering Council (PEC) in relevant Category duly renewed for the year 2024-2025. (MANDATORY).
- b. Receipt of renewal fee with Water & Power Department Gilgit-Baltistan for the year 2024-2025. (MANDATORY).
- c. No Sick/ Litigation Certificate and No Black listing certificate duly issues by Water & Power Secretariat and Affidavit of no delayed project in hand duly issued by 1st Class Magistrate. (MANDATORY).
- d. Earnest money (02%) shall be provided with bidding documents. (MANDATORY).
- e. Conditional tender will not be accepted.
- f. No tender will be sold on the date of opening of tender.
- g. Bid received after due date & time should not be considered.
- h. Bidding document can be collected from the Office of the Executive Engineer Civil Engineering Division W&P Department Gilgit-Ghizar on cash payment Rs. 4,000/- (non-refundable) during office hours by submitting written application along with CDR, original/valid PEC registration certificate in person, original PEC certificate, original no Sick/ no Litigation Certificate/ no Black listing certificate duly issues by Water & Power Secretariat and Affidavit of no delayed certificate duly attested by 1st Class Magistrate.
- i. The information provided by the bidders if found ambiguous will be verified and in case of fake one, the tender of firm will be cancelled and face immediate/appropriate penal action as per Rules/Laws.
