The said application shall be mandatory and accompanied by the following documents.


MANDATORY CONDITIONS:-

- PEC valid Registration for CFY (2024-25) having relevant code and category.
- Renewal receipt of registration with GB-C&WD for CFY (2024-25).
- Enlistment receipt procuring Agency.
- CNIC of the prospective bidder/ firm/ JV.
- No. Litigation Certificate and No Black listing certificate issued by Communication & Works Secretariat and Affidavit of No delayed project in hand duly attested by 1st class Magistrate.

TERMS & CONDITIONS:-

- The bidding documents will be issued to firms/contractors after scrutiny of documents by the committee and upon submission of 2% bid security in shape of CDR issued by any schedule bank in Pakistan. The contractor / owner of the firm must collect document in person.
- Rates quoted below 10% of the Technical Sanction shall be required to provide along with his bids an additional performance guarantee of 50% of the differential amount (between TS and Bid) in shape of CDR from any schedule Bank of Pakistan.
- No bid shall be accepted beyond closing time as mentioned against each work.

04. In case of Gazette holiday/local holiday/surprise engagement tender shall be opened on next working day without further intimation.
05. Bids shall be opened in the office of the Executive Engineer B&R Division C&WD Skardu.
06. The contractors debarred by any Region/Division and notified by Works Secretariat shall not be eligible to participate in the bidding process.
07. The bid security of unsuccessful bidders shall not be released before the issuance of work order to the successful bidder.
08. Power of Attorney for bidding should be in Rs. 100/- stamp paper in original mentioning the project name with employer stamp and also attested by the 1st Class Magistrate.
