- For Complete set of equipment specification and terms and conditions, please read the instructions carefully, laid down in bidding documents.
- 3. Mode of procurement is DDP basis. And Bid security will be 3 % of the estimated cost for item
- 4. Rates will be inclusive of all relevant taxes.
- If the tender day is observed as National or local holiday, tender will be opened on the next working day at same time and venue.
- As per GBPPRA Rules 2022 "Single stage two envelope bidding procedure" will be adopted for open competitive bidding.
- Tender without call deposit receipt (CDR) (only schedule bank) will not be entertained, bank open or cross cheques will be not accepted.
- Interested Firms are required to provide detailed information of their capacity/qualification to
 perform this assignment as detailed in the Bidding Documents. The Firms are allowed to make
 Joint Ventures (JVs) to enhance their capabilities; however, the lead firm must be decided.

All interested bidders are advised to submit a comprehensive Technical Compliance Sheet (hard and soft copy) as per given specifications of required item vs offered item with page number and attach original brochures / catalogs (Plain A4 page) highlighting the required parameters in specifications.
