Terms and Conditions:

- 1. **Bid Security**: A call deposit of Rs. 374,700/- in favor of the Principal Government Boys Degree College, Aliabad, Hunza, must be submitted with the tender.
- 2. **Bidding Procedure**: The procedure of biding will be entertained by adopting Rule 36(b) of PPRA 2004 and GB Public Procurement Rules, 2022 clause 39(b) **"Single-stage Two Envelops Procedure"** and selection will be made following the Quality and Cost Based Selection (QCBS) procedure.
- 3. **Submission of Bidding Documents**: All proposals, complete in all respects, in accordance with the instructions provided in the bidding document (properly prepared content page, binding, paging, flagging of all required documents) in sealed envelopes should reach on the above mentioned date and time in the office of the undersigned and the Technical Proposals at 1st stage shall be opened on the same day on the time given above whereas the original financial proposal along with the bid security will remain with the procuring committee. Furthermore, only "Typed" financial bid will be considered valid. In other words, hand written financial bids will not be accepted.
- 4. **Blacklisting**: The firm or contractor must not be blacklisted by any government department.
- 5. **Financial Stability and Experience**: The firm or contractor must be financially sound and have adequate experience. Additionally, the shop/showroom must be located within any region of Gilgit Baltistan.
- 6. **Supply and Termination**: Failure to supply the goods within the stipulated time after the supply order is issued shall result in the cancellation of the tender, and the bid security amount shall be forfeited in favor of the government.
- 7. Financial Year: The tender shall be valid for the financial year 2024-2025.
- 8. **Pricing and PPRA Rules**: Prices must be competitive and follow the PPRA rules. Prices that are significantly higher or lower than the market rates shall not be accepted. No changes in the rates shall be allowed later.
- 9. **Tender Documents**: Tender forms and documents can be obtained from the undersigned office during office hours upon payment of a non-refundable fee of Rs. 8,000/-.
- 10. **Scope of Change**: The procuring committee reserves the right to increase/decrease the number of items/quantities or delete the item for the reason thereof.
- 11. **Reliability of Bidder**: The bidder should be registered with SECP otherwise registered under Form-C. The bidder providing unsubstantiated and/or incorrect information is liable to legal action and/or disqualification.
- 12. **Rescheduling**: In case of a Local Holiday, the bidding process will be held on the next working day at the same time and venue.
