Terms and conditions:

1. Sealed tenders are required to be submitted to AC office Tangir on or before the date mentioned against category before the closing date and time, which will be opened by the procurement committee in presence of contractors/ supplier or their authorized representatives at AC office Tangir on 27th August, 2025 at 10:30 am. Late submitted bids shall not be accepted.
2. Contractor / supplier may offer only the category of tender in which he has complete setup (own shop/ store/workshop) with documentary evidence. The contractor/supplier must have adequate supply in Tangir and the firm will be bound to supply the demanded items/services at Tangir
3. The award of the bid shall be based on the most advantageous bidder. Tender for each category must be offered by mentioning name of category in bold letters on sealed envelopes.
4. The rates of items not covered in the prescribed form will be determined in accordance with the prevalent retail price in open market at the time of supply.
5. The bid security / call deposit (refundable) in the shape of bank draft / pay order any scheduled bank in the name of Assistant Commissioner, Tangir to be attached with the bidding documents. No bidding documents will be accepted / entertained without call deposit being submitted along with it.
6. Bank statement for last two years, five years work experience in relevant field, registration certificate, CNIC of owner, letter pad of firms with address and vendor number and telephone number and affidavit mentioning the firm has not been blacklisted previously duly verified by Magistrate 1st Class must be attached with the bidding documents.
7. All contractors must fulfill the technical terms and conditions of the bidding documents.
8. There will be no compromise on the quantity and quality of the items after acceptance of bid.
9. Unjustified/unrealistic rates that are below 20% from the market rates will be liable to be rejected.
10. The procurement committee reserves the right to accept or reject any or all the bids as per relevant instructions / guidelines of PPRA.
