The tender documents containing the detail of work and items (BOQs) will be available from the date of publication of this tender which can be obtained from the CKNP office during office hours on payment of the fee fixed by Government of Gilgit-Baltistan through Gilgit-Baltistan Finance Act 2025. (non re-fundable).
3. Rates quoted below 10% from the estimated cost, the bidder may provide an additional performance guarantee (differential amount) in shape of bank Call Deposit Receipt (CDR) from any scheduled bank.
4. The bids should reach this office within mentioned date and time after which no bid will be entertained.
5. Tender form will not be sold on the day of opening of tender.
6. Income tax will be deducted at source as per rules.
7. Incomplete Tender will not be accepted in any case.
8. The Directorate of CKNP may reject all bids or proposals at any time prior to the acceptance of a bid or proposal as per Rule 33(1) of PPRA without assigning any reason thereof.
