PRE-BID MEETING:

The pre-bid meeting will be held on **3rd September 2026, at 11:00 AM** in the office of the Additional Medical Superintendent, PHQ Teaching Hospital Gilgit.

ELIGIBILITY FOR PARTICIPATION:

Only those firms who have purchased the bidding documents shall be eligible to participate in the pre-bid meeting. Firms must provide proof (copy of treasury challan) of purchase of the bidding documents at the time of the meeting.

Bidders who do not participate in the pre-bid meeting shall not be entitled to raise any objection or question regarding the bidding documents at any stage or before any forum, as the decisions and clarifications made during the pre-bid meeting shall be considered final. However such bidders shall remain eligible to participate in the bidding process subject to fulfillment of all other requirements of the bidding documents.

GENERAL TERMS & CONDITIONS

1. Tender received after the stipulated date and time shall not be entertained.
2. Bid security/CDR from a scheduled bank must accompany the bid; otherwise, the offer shall be rejected.
3. Only registered firms having valid licenses and registrations shall be eligible to participate.
4. Quotations must be submitted on the firm's original letterhead, duly signed and stamped.
5. If the tender opening date is declared a public/local holiday, the tender shall be opened on the next working day at the same time and venue.
6. Rates quoted must be computerized and free from cutting, overwriting, or erasing.
7. The bidder shall submit an original and valid affidavit regarding non-blacklisting and absence of litigation against the firm/company.
8. The procuring agency reserves the right to accept or reject any or all bids in accordance with applicable procurement rules.
9. The successful bidder shall furnish a Performance Security equal to ten percent (10%) of the annual estimated contract value within the prescribed period after issuance of the Letter of Acceptance in the form of CDR.
10. Tender document having specific terms and conditions are available, which can be obtained from the office of undersigned during duty hours on written request with treasury challan of tender document fee as per finance act/directives 2025-26.
11. Without treasury challan of tender fee, no tender copy will be issued.
12. The successful bidder shall establish and maintain a medicine dispensing facility within PHQ Teaching Hospital Gilgit or easily accessible point near the hospital premises.
