
MUST MEET TERMS AND CONDITIONS:

- Original No litigation/No sick scheme certificate on Stamp Paper for year 2025-26 Duly attested by 1st Class magistrate.
- Original renewal receipt in Works Department GB is required for the financial year 2025-26.
- Copy of National Identity card (owner of the firm).
- Only project specific power of attorney on the behalf of CEO/MD/Director of firm is accepted if provided on **judicial stamp paper duly sign and stamp by 1st Class Magistrate.**
- All Bids must be accompanied with 3% Earnest Money (E/M) Clearly Mentioned the Name of firm in Shape of CDR from any Schedule bank of Pakistan in the Name of **DEPUTY DIRECTOR WATER MANAGEMENT & IRRIGATION DISTRICT GHIZER.**
- The Contractor who quoted Tender rates more than 10% Below of T/S Cost Shall be required to Provide along with bids an additional performance guarantee of 50% of the differential amount (between TS and bid) in shape of CDR From any Schedule bank of Pakistan. In case of failure to produce the required differential amount of bid by the bidder along with his bid documents, the bid shall be rejected and original CDR amount shall be forfeited.
