
**RE-INVITATION FOR PROPOSALS**

It is hereby informed to all prospective Bidders that the invitation for Bids vide above referred letters was previously postponed due technical reasons. The Employer after fulfilling all codal formalities and necessary changes made therein by issuing an addendum to bidding document, is hereby re-advertised with following terms and conditions.

**CONSTRUCTION OF 90 METER RCC BRIDGE OVER CHALT RIVER AND CONSTRUCTION OF 1.6 KM APPROACH ROAD AT BADULUS NAGAR-II.**

01. Government of Gilgit-Baltistan, Communication & Works Department (C&WD) office of the Executive Engineer B&R Nagar invites sealed bids from eligible construction firms registered with Income Tax departments having valid Pakistan Engineering Council (PEC) registration in the Category C-3 for individual bidder or as stated in Bid document in case of JV (with specialization in CE-01 & CE-02 for the year 2024-25).
02. Bids are invited from firms/JV having experience of successful design and execution of project are eligible to apply and shall be responsible to undertake the project in EPC basis. Completion period of the project is 720 days.
03. Bidding document and TORs along addendum to bidding documents shall be issued to Firms/JV on request to employer by deposit of Rs.20000/- through challan in the head of Account G10407-PWD remittance from the Treasury office/NBP Sikenderabad branch.
04. The Procurement method shall be "Single Stage – Two Envelope Procedure" the firms/JVs will be required to submit two separate sealed envelopes containing Technical and Financial Proposals. Technical Proposals must also include detail engineering design and feasibility study of the project along bid security amounting to Rs.6431580/- (2% estimated cost) in shape of CDR from any schedule bank which shall be duly verified from quarter concern after submission of bids.
05. If the bidder quoted rates below 10% of Engineer Estimate cost shall be required to provide along with his bid an additional performance guarantee of 50% of differential amount (b/w engineer estimate cost and bid cost) in shape of CDR from any schedule bank of Pakistan along with the financial bid.
06. Pre-Bid Meeting will be held on 12<sup>th</sup> November 2024 at 1200 hours in the Office of the Superintending Engineer Hunza-Nagar Circle C&WD HQ Gilgit. The bidders are advised to visit the site before attending the Pre-Bid Meeting. Moreover, the bidders in person or advised to depute only a single authorized representative to attend the proceedings.
07. The Bids in sealed envelope, prepared in accordance with the instructions contained in the Bidding Document, must reach at the Office of the Superintending Engineer Hunza-Nagar Circle C&WD HQ Gilgit on or before 28<sup>th</sup> November 2024 until 1500 Hours. Envelope containing "Technical Bid" will be opened on the same day at 1530 Hours as specified in the Bidding Document.
