GENERAL TERMS AND CONDITIONS:

- Registration with Pakistan Engineering Council in the relevant category for the year 2025-26. **(Mandatory)**.
- Tender copy will be issued/sold on provision of bid security in shape of CDR from any schedule Bank of Pakistan in the name of **Executive Engineer W&P Civil Engineering Division Skardu-Shigar**. **(Mandatory)**
- If the quoted rates seems unreasonable/unbalanced from Engineering Estimate, the bidder shall has to submit an equal amount in the form bank CDR any schedule bank of Pakistan valid till completion of the work, else tender will be rejected. **(Mandatory)**
- No tender form will be sold on the date of opening of tender.
- Tenders with incomplete supporting documents shall not be accepted, and furnishing incorrect information shall be liable to legal action.
- An affidavit on stamp paper of Rs.100/- must be accompanied with the tender documents to the effect that the bidder has never been blacklisted by any Government/ Semi-Government Organization/PPRA.
- The tender shall be considered item mentioned and firm shall be bound to supply/provide goods/services at rates quoted in tender during the financial year 2025-26.
- Firms quoting inappropriate rates with respect to market rates, to bring itself / himself lower shall not be considered.
- The Contractor must have his own shop/workshop to participate in the tender. Firm/ Contractor must have at least Ten (10) years' experience for categories with at least five (05) year bank statement must be attached and can only participate in tender and attached with tender documents.
- All type of taxes/charges applicable under rule will be deducted from each bill.
- The department reserves right to accept or reject the tender according to PPRA Rule-33(1)
- In case of Gazette holiday/local holiday, tender shall be opened on next working day without further intimation.
