INVITATION FOR BIDS

Sealed bids are invited for procurement of Bulk Medicines, Surgical Disposables, Sutures, Dental Material, Dressing Material, Dialysis Material & other Misc /consumables items etc. for Health institutions/Hospitals & Vertical Programs of GB Health Department during the financial year 2026-27 under regular, development / vertical programs budget which will be received up to 11:00 A.M on 10.06.2026 in the office of the Director Health Services (Planning & Procurement) will be opened on the same day at 11:30 A.M in the presence of bidders or their authorized representatives who choose to attend the meeting of bid opening. Pre-bid meeting will be held as on 20th May, 2026 at 11:00 AM in the office of Director Planning & Procurement Health Department GB situated at Jutial Gilgit.

1. Bidding shall be conducted through Single Stage - Two Envelopes bidding procedure of GB Public Procurement Rules. The envelopes shall be marked as **“TECHNICAL PROPOSAL”** and **“FINANCIAL PROPOSAL”** in bold and legible letters. Financial Proposal of bids found technically non-responsive shall be returned un-opened to the respective bidder.
2. For supply of pharmaceuticals, surgical disposables, surgical sutures, dental materials, dressing materials, dialysis material & other Misc /consumables items etc. all Manufacturers/ Authorized Importers, authorized distributors can participate according to technical criteria mentioned in the bidding document.
3. Bid Security/Call Deposit Rs 40, 00,000/- (Forty hundred thousand rupees only) in form of CDR from any scheduled bank of Gilgit-Baltistan in favor of Director Health Services (Planning & Procurement) must be attached with the bids. Bank guarantee as an instrument of bid security will not be accepted.
4. Bids shall remain valid for 30.06.2027.
5. A complete set of bidding document including detail specifications, quantity, terms & conditions and evaluation criteria can be obtained through authorize person having authority letter up to 09-06-2026 during office Hours on submission of written application on original letter pad and duly sign & stamped along with original treasury Challan for payment of non-refundable prescribed tender fee amounting to **Rs. 20,000/- (Rupees Twenty thousand only)** as per GB Finance Act, from Director Planning & Procurement Health Department GB Jutial Gilgit.
6. All taxes/ duties levied by Govt. will be charged from the bills under admissible rules.
7. All bids should be submitted in tape binding duly sealed. All documents should contain proper page marking, attached in sequence should have signatures of authorized person. Moreover, signing and stamping of each page of bidding documents are mandatory failure to comply will disqualify the bidder technically.
8. All bidders must attach bid data sheet consisting of complete list of quoted items at beginning of technical bid.
9. All bidders must attach index having complete page numbers at the beginning of technical bid.
10. It is mandatory for bidders to provide all information related evaluation criteria in one profile with page marking, failure to comply will disqualify the bidder.
11. All bidders shall furnish an affidavit /certificate that they are neither black listed nor in conflict with government anywhere in territory of the Gilgit-Baltistan, AJK, and provinces of Islamic Republic of Pakistan.
12. If the distributor quotes any firm (Manufacture / Importer/Sole Agent) which are blacklisted by PPRA anywhere in Pakistan & GB in that case legal proceeding will be done against both the distributors and the quoted firms as per GB PPRA Rules.
13. All bidders shall furnish an affidavit of that they are accepting all the terms and conditions of Bidding Document.
