TERMS & CONDITIONS:

- 1. The tender rates will stand valid only for procurement of the items listed above against the projects mentioned above only.
- 2. The tender/bidding document of only registered firms/dealers/suppliers/contractors (Form-C/SECP/PEC) shall be entertained.
- 3. The Contractor/Supplier must be sole proprietor/joint venture having his own complete setup (shop/store/warehouse) containing adequate supplies in Gilgit-Baltistan and shall not be a subcontract. Partial bids will be rejected outright and conditional bids will be treated as non-responsive.
- 4. The Procurement Committee shall physically inspect/check the bidder's Shop/Store/warehouse to satisfy itself that the same exists with adequate supplies along with technical expert/staff.
- 5. Bid price against each item shall not be unrealistically higher or unrealistically lower than the prevailing general market price.
- 6. Incomplete bid documents with incomplete details (specifications/strength/manufacturer etc) shall be rejected straight away.
- 7. 2% of the bid value in the form of call deposit issued by a Schedule bank/KCBL GB may be deposited in favor of Deputy Director Education Hunza otherwise bids shall be liable to be rejected technically.
- 8. Successful bidders shall have to submit 10% performance security in shape of CDR/Pay orders within 10 days after bid opening.
- 9. After acceptance of the bid, a separate contract agreement deed shall have to be undertaken between the bidder & procuring agency i.e. office of DDO Deputy Director Education Hunza.
- 10. The Chairman of procurement committee reserves the rights to accept or reject in part or whole of tender on violation of any financial rules and assigning/recorded reasons there-off.



- 11. Bidder will be selected on the basis of the rates offered and his experiences & performance in relevant field experience.
- 12. The Company/Firms Shall have to submit affidavit for not have been blacklisted on legal stamp paper.
- 13. Tender process will be completed in accordance with the relevant rules of GB PPRA 2022 (as amended and guidelines issued there under from time to time) and single stage two envelopes procedure.
- 14. Bidding documents can be obtained from the office of the DDO Deputy Director Education Hunza w.e.f May 08,2025 @ Rs. 4000, as per Finance Act-2024.
- 15. Rates of items, quoted/written in items specification list must be typed and in no case shall be accepted if filled with hand writing.
- 16. Furniture and all other items will have to be supplied at the respective schools of District Hunza. Rates will be inclusive for all relevant taxes.
- 17. Claims/bills shall be entertained, as per release of funds by the Finance Department Gilgit-Baltistan and in light of the recommendations by the physical verification committee.
- 18. In case of official holiday on the day of closing /opening of bids, next working day will be treated as closing date.
