1. Sealed tenders may be submitted to undersigned before the closing date and time, which will be opened by the committee on above mentioned date and time in presence of the contractors/suppliers or their authorized representatives at DIG Police Special Branch Gilgit-Baltistan, Gilgit.
2. Contractor/Supplier/ has complete set up (own shop, and past experience with documentary evidence.
3. The Contractor/Supplier must be sole proprietor/ Certificate of Chamber of Commerce/ and having NTN number, having his own complete setup (shops) containing adequate supplies in Gilgit Town and he will be bound to supply demanded items at the DIG Police Special Branch Gilgit-Baltistan, Gilgit.
4. The Bid Security/call deposit in shape of Bank Draft/Pay Order by a **scheduled bank** in the name of "**DIG Police Special Branch Gilgit-Baltistan, Gilgit**" may be attached with the bidding/tender documents. **Tender without call deposit from a scheduled bank, will not be accepted.**
5. **Firms Quoting unrealistic Low Rates as exaggerated high rates as compared to market rates could be straight away rejected.**
6. The rates of items if not covered in the "Prescribed Form" will be determined in accordance with the prevalent retail price in the open market at the time of supply.
7. Tender documents fee will be charged @ Rs.4,000/- according to GB Finance Act-2024 .
8. Conditional, ambiguous & incomplete tenders shall not be accepted.
9. Bank statement for the last 03 years work Experience **(the closing balance not less than 2 million on 30.06.2024)** in relevant field and Registration Certificate, Vendor Number must be attached with bidding documents duly attested.
10. The competent authority reserves the right to accept or reject the tender as per relevant instructions/guidelines of GB PPRA rules.
