TERMS AND CONDITIONS:-

1. Sealed tender on Company letter head may be submitted to undersigned on or before the date mentioned against each categories on or before closing date and time in presence of the contractor/suppliers or their authorized representatives at Minerals Industries, Labour & Commerce Secretariat new Secretariat Building Jutiya Gilgit.
2. Contract/ Suppliers may offer only the category of tender in which he has complete setup (Own Shop/store/Work Shop with Documentary Evidence with two year experience certificate).
3. The Contract/Suppliers must have adequate supply in Gilgit-Baltistan and the firm will be bound to supply demanded items/ Services at Islamabad also.
4. Separate envelopes containing technical and financial proposal must be submitted before the closing date and only those bidders will be qualified for financial bidding that fulfill the technical terms and conditions.
5. Tender for each category must be offered mentioning name of category in bold letters on sealed envelope.
6. The bid security/ call deposit (refundable) in shape of bank draft/pay order by a scheduled bank in the name of Deputy Secretary Minerals Industries Labour & Commerce Gilgit Baltistan may be attached with the bidding /tender documents. No tender without call deposit from a schedule bank will be accepted.
7. The bidding documents of only registered firms/ dealers/supplies/contracts shall be entertained.
8. The rates of items if not covered in the "Prescribed Form" will be determined in accordance with the prevalent retail price in the open market at the time of supply over and above or low rate with open market and unjustified rates are not acceptable .
9. All kind of taxes applicable (if any) will be inclusive in the bid price and born by the firms/ dealers/suppliers/ contractors.
10. Conditional, ambiguous and incomplete un justified rates/ tenders shall not be accepted.
11. Firm registration certificate," Form C", CNIC of the owner must be produced .
12. The tender opening committee reserves the right to accept or reject any one or all the tenders as per relevant instructions/ guidelines of PPRA GB rule, 2022.
