A foreign bidder is entitled to bid only in a joint venture with one or more Pakistani constructor(s) in accordance with the relevant provisions of the PEC bye-laws.

5. All Bids must be accompanied by a Bid Security, as mentioned above, in the amount as set forth in Clause IB-15of the Instructions to the Bidders and other terms as per bidding documents.
6. Bids will be received at the office of the Secretary Communication &Works Department Khazana Road Gilgit until 1200 hours on **5th November 2024**. Technical/Financial Bids will be opened at 1230 hours on the same day, in the presence of those Bidder’s representatives who choose to attend the opening of bids at the same office.
