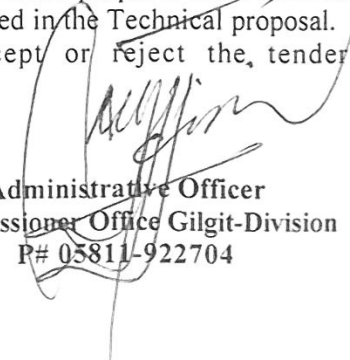

2. The tender documents must reach office of the undersigned on or before the date and time mentioned above. Tender documents will be opened on the same day as per the schedule given above in presence of Contractor or his duly authorized representative.

GENERAL TERMS AND CONDITIONS:

1. Earnest money as mentioned above must be attached with the tender documents in the form of demand draft/pay order in the name of Commissioner Gilgit Division from any schedule bank.
2. Tenders with incomplete supporting documents shall not be accepted, and furnishing incorrect information shall be liable to legal action.
3. An affidavit on stamp paper of Rs. 100/- must be accompanied with the tender documents to the effect that the bidder has never been blacklisted by any Government/Semi-Government Organization/PPRA.
4. The firm/contractor winning the bid shall be bound to supply the items to the Commissioner Office till 30th June, 2027.
5. Firms quoting irrational/unjustifiable/ in appropriate rates (even of a single item) with respect to market rates shall be rejected.
6. Tender Forms/NIT is available for interested applicants in lieu of **Rs. 10000/-** non-refundable duly deposited in the National Bank of Pakistan through Treasury Challan (**Tender Repair of Transport Regular / IS Vehicles FY, 2026-2027**).
7. Tender Forms/NIT is available for interested applicants in lieu of **Rs. 8000/-** non-refundable duly deposited in the National Bank of Pakistan through Treasury Challan (**Unforeseen Expenditures Purchase of Relief items / Purchase items for Disaster Mitigation Works FY, 2026-2027**).
8. Tender Forms/NIT is available for interested applicants in lieu of **Rs. 4000/-** non-refundable duly deposited in the National Bank of Pakistan through Treasury Challan (**Tender others/Exhibition and Fairs FY, 2026-2027**).
9. The Single Stage-two envelope procedure shall be followed and tender shall be evaluated as per weightage/ratio of 70:30 formulae i.e. 70 marks for technical proposal and 30 marks for financial proposal. Minimum 60% marks need to be obtained in the Technical proposal.
