Bidding documents can be obtained by the interested and eligible bidder on submission of application and non-refundable fee mentioned above against each work from the office of the Executive Engineer B&R Division Skardu, Commissioner Baltistan office & Deputy Commissioner Office Skardu. The tender fee will be accepted through Treasury challan on account of cost of tender form clearly showing name of contractor/work duly passed/endorsed by NBP Skardu Branch in the relevant head of account G-10407 remittance! The said application shall be mandatory and accompanied by the following documents.

MANDATORY CONDITIONS:-

- PEC valid Registration for CFY (2025-26) having relevant code and category.
- Renewal receipt of registration with GB-C&WD for CFY (2025-26).
- Enlistment receipt procuring Agency.
- CNIC of the prospective bidder/ firm/ JV.
- No. Litigation Certificate and No Black listing certificate issued by Chief Engineer C&W Department - Baltistan Region Skardu and Affidavit of No delayed project in hand duly attested by 1st class Magistrate.

TERMS & CONDITIONS:-

- The bidding documents will be issued to firms/contractors after scrutiny of documents by the committee and upon submission of 2% bid security in shape of CDR issued by any schedule bank in Pakistan. The contractor / owner of the firm must collect document in person or by the authorized representative having original power attorney mentioning the name of above project
- Rates quoted below 10% up to 25% of the Technical Sanction shall be required to provide along with his bids an additional performance guarantee of 50% of the differential amount (between TS and Bid) in shape of CDR from any schedule Bank of Pakistan.
- No bid shall be accepted beyond closing time as mentioned against each work.
- In case of Gazette holiday/local holiday/surprise engagement tender shall be opened on next working day without further intimation.
- Bids shall be opened in the office of the Executive Engineer B&R Division C&WD Skardu.
- The contractors debarred by any Region/Division and notified by Works Secretariat shall not be eligible to participate in the bidding process.
- The bid security of unsuccessful bidders shall not be released before the issuance of work order to the successful bidder.
- Power of Attorney for bidding should be in Rs. 100/- stamp paper in original mentioning the project name with employer stamp and also attested by the 1st Class Magistrate.
