- Original departmental No Litigation /No Sick Scheme certificate on the behalf of office of the Secretary Works C&WD in prescribed format for year 2026- 2027.
- Original renewal receipt in Works Department GB is required for the financial year 2026-2027.
- On production of original CNIC & Pakistan Engineering Council Registration Certificate year 2025-2026(as extended by PEC upto 31st August, 2026).
- Copy of National Identity Card (Owner of the firm)
- Only Project specific power of attorney on the behalf of CEO/MD/Director of firm is accepted if provided on judicial stamp paper duly sign and stamp by 1st Class Magistrate.
- Firms/JVs must provide earnest money in the form of call deposit receipt (CDR) in favor of the Executive Engineer B&R Division C&WD Ghizer from any scheduled bank.
- In case of receipt of abnormally low bids below 15% from technically sanctioned cost, the bidder must provide an additional performance guarantee (differential) amount equal to 10% of the difference amount between bid and TS cost) in shape of CDR only from any scheduled bank of Pakistan in favour of the Executive Engineer C&WD Ghizer as indicated in NIT which should be submitted along with the financial bid and Insurance Guarantee will not be entertained for this purpose.
- The bids having bid price lower than 25% shall be liable to be rejected. In case of same disputed rates within 25% initially rates upto three decimal places shall be assessed for the competition. In case of further dispute/deadlock, it will be decided through a toss/draw as per directives vide Chief Engineer, C&WD Gilgit Region File No. E6-1(195)Cir/2025-26/2919 dated 07th Nov, 2025.(will be attached in NIT to be sold.
