INVITATION FOR BIDS

The LG&RD District Hunza represented by Executive Engineer LG&RD District Hunza, (the "Employer") has received funds from Government of GB through GB-ADP #1280 towards the cost of Rs.50.750 million for "REHABILITATION OF SEWERAGE SYSTEM IN DISTRICT HEADQUARTER ALIABAD" and invites sealed bids from eligible bidders (Single entity or in JV) on **National Competitive Bidding (NCB) procedures** who can prove their eligibility and qualification as mentioned in the Bidding Documents for the works and have not been Black Listed by any Government agency/department/organization. The Bidding is open to all Eligible Bidders. The Scope of Work includes (Land Development, Const. of Bio Filter, Const. of Septic Tank., Const. of Man Hole, Rehabilitation of Septic tank, Bio Filter, Laying of UPVC Pipes)

The Employer invites sealed bids, under **Single Stage-Two Envelope (SSTE)** bidding procedure from eligible firms or persons licensed by the Pakistan Engineering Council renewed up to June 2025, in the relevant category (C-5 & above)/code for the specialization (CE09).

2. The bidding documents can be obtained from the office of the **Executive Engineer LG&RD District Hunza located at Old Silk Route Aliabad Hunza** from the date of publication till **17-12-2024** during office timings. Tender fee of Rs.12000/- (Non-refundable) in the form of Cash along with 5% Bid Security in the shape of CDR from any scheduled bank of Pakistan in the name of Executive Engineer LG&RD District Hunza to be attached with the application for issuance of bidding documents. Bidding documents will be issued by applying on original letter-pad by owner of firms or their authorized representatives having project Specific registered power of attorney (on affidavit). No proxy will be allowed to participate. All bids must be accompanied by a Bid Security amounting to Rs.2537500/- (Twenty Five Lac Thirty Seven Thousand Five Hundred Only) in form of CDR from any scheduled bank of Pakistan in favor of the Executive Engineer LG&RD Hunza and is to be **made part of Technical Bid**.

3. The completed bids must be delivered to the office of **Executive Engineer Office LG&RD District Hunza at Old Silk Route Aliabad Hunza** at or before 1:30 PM on 18-12-2024. Bids will be opened at 2:00 PM on 18-12-2024, in the presence of bidder's representatives who choose to attend. The Employer may not be responsible for any cost or expenses incurred by the bidder in connection with preparation or delivery of the bid.

4. Additional performance guarantee will be governed through Clause **IB.32 & sub clause 32.3** of bidding documents.

In the case of gazette /Local Holiday tender will be opened on next working day without further intimation and time completion period of the project is 24 months.

The Employer reserves the right to accept or reject any bid and to annul the bidding process and reject all bids in line with PPRA rules, at any time prior to award of Contract.
