INVITATION TO BID

1. The Employer, Communication & Works Department (C&WD) Gilgit-Baltistan through Project Director has received the approval of funds from the Government of Pakistan through PSDP and it is intended that part of the proceeds of the funds will be applied to eligible payments under the Contract for the construction of a project namely *"Inter-Regional Connectivity between Baltistan Division and Diamer-Astore Division (Construction / Metaling of Road from Gorikote Astore to Shagarthang Skardu)"*. Bidding is open to all eligible Bidders.
2. The Employer invites sealed bids, under **Single Stage-Two Envelope** bidding procedure, from eligible firms or persons licensed by the Pakistan Engineering Council in the appropriate category and having specialized codes for the Works. A foreign bidder is entitled to bid only in a joint venture with a Pakistani constructor in accordance with the relevant provisions of PEC bye-laws.

7. The Technical Bid must be accompanied by a Bid Security of the amount mentioned above in the form of CDR or Bank Guarantee from a Scheduled Bank in Pakistan in favor of the Project Director IRC, Astore-Skardu Road (ASR).
8. The complete set of Bids (Technical & Financial) must be delivered to the Office of the Secretary C&W, C&W Secretariat, Khazana Road, Gilgit at or before 11:00 am (PST), on 17th July 2025. Bids will be opened at 11:30 am (PST) on the same day, in the presence of the bidder's representatives who choose to attend at the same address.
