(A). The project titled "**Metaling of Existing Road from Oshkhandasto Danyour**" was advertised on Pre-Qualification method of bidding widely circulated through PPRA and print media on 30th October, 2024, total Fifty-five (55) Applicants participated in the bidding process out of which 35 Nos have qualified the criteria of pre-qualification while 20 Nos applicants were not pre-qualified. Out of 20 not pre-qualified applicants 04 Nos applicants opted for GRC i.e. M/s Raiz & Omer Associates, M/s Mavrick Const. & builders Pvt Ltd, M/s Safdar Jalalabad & Sons & M/s Muhammad Ali Jinnah JV M/s Suleman & Sons Bar Enterprises for redressal of their grievances.






