- Tender (Technical proposal) will be opened at the office of the Superintending Engineer Diامر-Astore Circle office Chilas Diامر on above mentioned date and time.
- Procurement shall be carried out in accordance with Notification issued by the Communication and works Secretariat GB vide Notification No. SEC-SO-D-9(28)/2024-25/2001 dated 29<sup>th</sup> May, 2025.
- The prospective eligible bidders may obtain bidding documents after payment of price of bidding documents and by submitting a written application personally or through an authorized representative with duly attested copy of power of attorney. The said application shall be mandatory accompanied by the following documents.

**MANDATORY CONDITIONS:**

- PEC Registration license in original renewal up to 30<sup>th</sup> June 2026
- PEC relevant category and Code.
- CNIC of the prospective bidders.
- Latest profile of the Contractor from PEC website.
- Affidavit of No litigation and No blacklisting.
- NOC of No litigation and No blacklisting renewal upto 30<sup>th</sup> June 2026 from Regional office GB
- Bid security as specified in shape of CDR/TDR from any schedule Bank of Pakistan.
- In case of JV agreement, proper format duly signed by all partners of JV clearly mentioning share of each partner lead and associate partner duly attested by Magistrate 1<sup>st</sup> Class shall be mandatory.
- Only single bid by one bidder either in form of JV or single bidder.
- Rates quoted below 25% of the technical sanction shall be considered as unworkable, however, the bidder quoting rates below 25% of T/S shall be required to provide along with his bids an additional performance guarantee of 50% of the differential amount (between T/S & Bid) in shape of CDR/Bank Guarantee from any schedule bank.
- In case of failure to produce the required deferential amount of the bid by the bidder along with his bid documents, the bid shall be rejected and security of such bidder shall be forfeited
