MANDATORY CONDITIONS:

- 1) PEC Registration license in original revenue upto 2024-25.
- 2) PEC relevant category and Code.
- 3) CNIC of the prospective bidders.
- 4) Enlistment with procuring Agency.
- 5) Affidavit No litigation, No Sick Project certificate and no blacklisting.
- 6) Renewal receipt for CFY 2024-25
- 7) Signature of bidder / witness on bidding documents is mandatory.

TERMS & CONDITIONS:

1. The bid security (mentioned against each work) of Engineer's cost estimate in form of Call Deposit issued by any schedule bank of Pakistan in the name of Executive Engineer B&R Division GB C&WD Diamer.
2. Conditional tender shall not be accepted.
3. In case of firm/company joint venture registered power of attorney and partnership deed in original must be produced for issuance of tender documents JV agreement, proper format PEC duly signed by all partners of JV clearly mentioning share of each partner lead and associate partner duly attested by Magistrate 1st Class shall be mandatory.
4. In Case of any local holiday tender will be opened next working day at same time & venue without further intimation.
5. The bidder quoting seriously unbalanced rates from the engineer's cost estimates and PC-1 provision will be dealt as per provisions of PEC bidding documents and amendments issued by the competent authority from time to time.
6. The additional performance security (differential amount) (between T/S & Bid) cost shall have to submit in shape of CDR from any schedule bank of Pakistan and the Guarantee bond of any Insurance Company shall not be entertained as per notification vide Communication & Works Secretariat No. Sec-SO-D-9(28)2024-25/2001 dated 29th May, 2025.
7. Tender documents will be issued to the bidder who have submitted fee in treasury account G10407(vide C&W Secretariat notification No. SW-7/104/2022-23/4977 dated 24th October, 2022) and shall show Challan in original while receiving the bid documents.
8. The power of attorney for receiving the bidding documents is discouraged keeping in view the mis-use of brouchers, however, the applicant shall have to provide a stamp paper duly attested by 1st class magistrate issued by the owner/ competent authority of the firm provided for the name of the specific work/scheme.
