- 01. The bids quoted above the estimated cost will be rejected outright.
- 02. A complete set of bidding documents may be obtained by interested and eligible bidder on submission of a written application and non-refundable fee mentioned above.
- 03. The bidders may acquire the bidding documents from the office of the Executive Engineer B&R Division C&WD Shigar during the office hours.
- 04. The fee of tender forms will be accepted through Treasury challan in the relevant revenue head of account **C-02706-Others**.
- 05. This advertisement is also available on PPRA website www.ppra.org.pk.
- 06. The bidding documents will be issued to firms/contractors subject to production of 2% bid security in shape of CDR/TDR issued by any schedule bank in Pakistan.

- 07. Rate quoted below 10% of the Technical Sanction shall be considered as unworkable, however. The bidder quoting rates below 10% of TS shall be required to provide along-with his bids an additional performance guarantee of 50% of the differential amount (between TS and bid) in shape of CDR from any schedule Bank.
- 08. In case of Gazette holiday/local holyday, tender shall be opened on next working day without further intimation.
- 09. Performance guarantee shall be @ 10% of the contract amount from any scheduled bank, in shape of CDR in favor of Employer valid for a period of 28 days beyond the bid validity date.
