2. Bidding documents can be obtained from DG GBES (Rescue 1122) office, until closing date i.e 4th February 2026 for the submission of bids on written request along with original treasury slip by depositing **Rs. 4000/- (Four Thousand only)** as tender fee in Treasury Office.

3. Bidding shall be conducted through rule 39(b) Single Stage – Two Envelopes bidding procedure of Gilgit Baltistan Procurement Rules, 2022. The envelopes shall be marked as "FINANCIAL PROPOSAL" and TECHNICAL PROPOSAL" in bold and legible letters. Financial Proposal of bids found technically non-responsive shall be returned to the respective bidder un opening their financial proposal.

4. Sealed bids are required to be submitted by the Bidders on above mentioned date positively in the Directorate General Rescue 1122 Gilgit Baltistan near Heli Chowk Jutial Gilgit. The bids received till stipulated date & time shall be opened on the same day and time as mentioned above in the presence of the notified tender committee and bidders or their authorized representatives who choose to attend. Late bids shall not be entertained. Bid security @ 5% of the estimated cost in the shape of Pay Order / Bank Draft / Call Deposit from schedule bank must be attached with the financial proposal.

5. All bids should be submitted in Tape Binding. All documents should contain proper page marking, attached in sequence as indicated for evaluation in the Bidding Documents and signatures of authorized person. Moreover, signing and stamping of each page of bidding documents/form is mandatory.

6. In case the date of opening or last date of sale is declared as a public holiday by the government or non-working day due to any reason, the next official working day shall be deemed to be the date of submission and opening of tenders accordingly. The time and venue shall remain the same.

7. Mandatory term and condition/ parameters for technical evaluation is mentioned in section IV of the bidding document.

- 1) The Procurement/Bidding Process shall be governed by the Gilgit Baltistan Procurement Rules, 2022.
