 - a) Tender on the Firm's letter paid with vendor number.
 - b) Call deposit worth to Rs.10000/- from a scheduled bank.
 - e. The rates of items if not covered in the "Tender Form" will be determined in accordance with the retail price fixed by the Chairmen Price Control Committee Shigar.
 - f. Government taxes applicable (if any) will be borne by the Firm/Contractor/Supplier.
