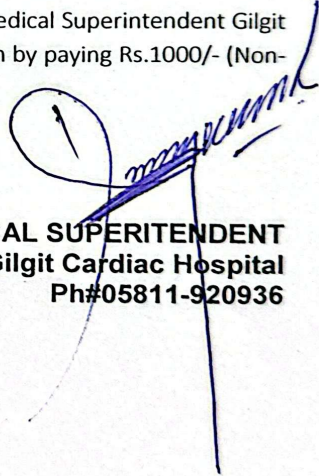

TENDER NOTICE

1. Sealed tenders are invited from the firms/registered contractors for the Pathology Laboratory of FY 2026-27 for the office of the Medical Superintendent, Gilgit Cardiac Hospital.
2. Interested firms must deposit earnest money @ 5% of the bid amount in the form of Call Deposit Receipt (CDR) from any scheduled bank, in favour of Medical Superintendent Gilgit Cardiac Hospital.
3. Sealed tenders must reach the office of the Medical Superintendent Gilgit Cardiac Hospital on or before 31st July 2026 at 11:00 AM. Tenders will be opened on the same day at 11:30 AM, in the presence of the bidders or their authorized representatives.
4. Conditional or incomplete tenders will be rejected.
5. Only registered firms from any National quality assurance Board or Agency are eligible to participate. A copy of valid registration must be attached; otherwise, the tender will be rejected.
6. MS Gilgit Cardiac Hospital reserves the right to terminate this contract with immediate effect if the pathology lab reports consistently fail to meet the standard requirements of pathology or if the reports are found to be substandard/erroneous.
7. MS Gilgit Cardiac Hospital reserves the right to terminate this contract at any time if the Hospital Lab becomes operational and is ready to provide the services outlined in this agreement.
8. This Agreement shall be valid for a period of One (1) years from the date of signing the contract. May be extended for a further period of Three (3) years on mutual written consent of both parties
9. Bidders may obtain a complete set of bidding documents along with evaluation criteria from the hospital office by submitting a non-refundable fee of Rs. 1,000/- (original receipt) at Gilgit Cardiac Hospital, Near Lalik Jan Stadium, Public Chowk, Jutial, and Gilgit.
10. The office reserves the right to accept or reject any or all bids as per PPRA Rules.
11. Only computerized rates will be accepted.
12. Equipment, Machinery, Reagents, Electricity bills, Human resources and Lab request form will be Responsibility of Contractor.
13. If any lab test are not listed in the tender document and are required in the future, the vendor will be responsible to supply them lowest discount rates.
14. These services will be offered only for the patients of Gilgit Cardiac Hospital, Not for the private patients..
15. Only Schedule Bank statement must be attached.
16. Two attested Copies of CNIC.
