For Camping Site Licenses at Deosai National Park

Parks & Wildlife Department, Gilgit-Baltistan invites sealed bids from eligible individuals, firms, and companies for the grant of Camping Site Licenses in Deosai National Park under the following categories with given locations & eligibility criteria;

1. Bidders may apply for one or more camping sites and categories as per eligibility; however, separate bids must be submitted for each site and category. **JV is not allowed.**
2. Open Competitive Bidding (Single Stage – Two Envelope) under applicable PPRA Rules. Last Date for Submission of bids is **11:00 AM 2nd June, 2026**. Bid Opening shall be done on the **same day at 11:30 AM** in presence of bidders/authorized representatives in the office of the undersigned.
3. The evaluation process shall be carried out on a weighted scoring basis, wherein 70% weightage shall be assigned to the technical proposal and 30% weightage shall be assigned to the financial proposal.
4. Detailed bidding document with all terms & conditions mentioned is available at the Office of the Chief Conservator Parks & Wildlife, Chinar Bagh, Gilgit.
5. Bids must be properly sealed and clearly marked: **“Camping Site License – Deosai National Park (Category ___)”**. Incomplete or late bids shall not be entertained. The competent authority reserves the right to accept or reject any or all bids in accordance with PPRA Rules.
