In pursuance of GB PPRA act and rules made thereunder, sealed tenders are invited from reputed, approved and registered firms/dealers/suppliers/contractors for procurement of the following categories of goods/services for Assistant Commissioner office Chilas for the financial year 2025-2026:

**NOTE:-** The prescribed form/bidding documents containing details of each category mentioned above may be obtained from the Accountant AC Office Chilas after publication of this notice, during office hours upon submission of applicable documents fees in treasury and submitting its copy thereof.

**TERMS AND CONDITIONS:**

1. Sealed tenders are required to be submitted to AC office Chilas on or before the date mentioned against category before the closing date and time, which will be opened by the procurement committee in presence of contractors/suppliers or their authorized representatives at AC office Chilas on 15<sup>th</sup> August 2025 at 1030 am. Late submitted bids shall not be accepted.
2. Contractor/supplier may offer only the category of tender in which he has complete setup (own shop/store/workshop) with documentary evidence. The contractor/supplier must have adequate supply in Chilas city and the firm will be bound to supply the demanded items/services at Chilas.

3. The award of the bid shall be based on the most advantageous bidder. Tender for each category must be offered by mentioning name of category in bold letters on sealed envelopes.
4. The rates of items not covered in the *prescribed form* will be determined in accordance with the prevalent retail price in open market at the time of supply.
5. The bid security/call deposit (refundable) in the shape of bank draft/pay order of any scheduled bank in the name of Assistant Commissioner Chilas to be attached with the bidding documents. No bidding document will be accepted/entertained without call deposit being submitted along with it.
6. Bank statement for last two years, five years' work experience in relevant field, registration certificate, CNIC of owner, letter pad of firms with address and vendor numbers and telephone number and affidavit mentioning the firm has not been blacklisted previously duly verified by Magistrate 1<sup>st</sup> class must be attached with the bidding documents.
7. All contractors must fulfill the technical terms and conditions of the bidding documents.
8. There will be no compromise on the quantity and quality of the items after acceptance of bid.
9. Unjustified/unrealistic rates that are below 20% from the market rates will be liable to be rejected.
10. The procurement committee reserves the right to accept or reject any or all the bids as per relevant instructions/guidelines of PPRA.
