The said application shall be mandatorily accompanied by the following documents.

1. PEC valid registration for CFY 2024-25 having relevant code and category.
2. Attested renewal receipt of registration with GB C&W for CFY 2024-25.
3. Attested CNIC of the prospective bidder/firm/JV.
4. Certificate of No Sick Scheme & No Litigation issued by respective Chief Engineer C&W Office of concerned region with proper dispatch entry duly attested and Affidavit of No delayed project in hand duly attested by 1st Class Magistrate.
5. Signature of bidder / witness on bidding documents is mandatory otherwise the bid will be straightaway rejected.
6. Late submission of bid will not be entertained.

TERMS & CONDITIONS:

1. The bidding documents will be issued to the firms/ contractors from the office of the undersigned after scrutiny of documents by the committee and upon submission of bid security in shape of CDR only issued by any scheduled bank of Pakistan. Pay order and Bankers' Cheque will not be accepted. The contractor/ owner of the firm must collect bidding documents in person. Power of attorney shall not be accepted. In case of Joint venture, partnership deed / agreement in original must be provided with the application on proper format duly signed by all partners of J.V clearly mentioning share of each partner duly attested by Magistrate 1st Class. The JV firms all documents must correlate i.e application in JV, treasury Challan in JV, and CDR in JV.
2. The employer reserves the right to accept or reject any bid and the bidding process and reject all bids with reasons thereof (if any).
3. Conditional tenders shall not be accepted.
4. In case of holiday, tender shall be opened on next working day without further intimation at the same time and venue.
5. Rates quoted below 10% from TS Cost shall be considered as unworkable however,
 - i) The bidder quoting rate below 10% of TS shall be required to provide along with his bids an additional performance guarantee of 50% of the differential amount (Between TS and Bid) in shape of CDR only from any scheduled bank of Pakistan that shall be verified during the evaluation of bids. Bond from Insurance Company shall not be accepted.
 - ii) In case of failure to produce the required differential amount of the bid by the bidder along with his bid documents, the bid shall be rejected and security of such bidder shall be forfeited.
6. The Bids shall be opened in the office of the Executive Engineer PHE & Building Division on above mentioned dates and time.
