- 3. Separate Bids are invited for the category of A,B & C.
- 4. Bids should be marked clearly for the desired item/head/category.
- An affidavit on stamp paper of Rs. 100/- must be accompanied with the tender documents to the effect that the bidder has never been blacklisted by any Government/ Semi Government Organization/ PPRA.
- 6. Irrational below market rates, as determined by the Tender Proceeding Committee, will not be considered and rejected.
