- vii. Late submission of bid will not be entertained.

TERMS & CONDITIONS:-

- O1. A complete set of bidding documents may be obtained by interested and eligible bidder on submission of a written application and non-refundable fee mentioned above.
- O2. The bidders may acquire the bidding document from the office of the Executive Engineer B&R Division C&WD Shigar during the office hours:

- O3. The fee of tender forms will be accepted through Treasury challan in the relevant revenue head of account C-02706-Others.
- 04. This advertisement is also available on PPRA website www.ppra.org.pk.
- O5. The bidding documents will be issued to firms/contractors subject to production of 2% bid security in shape of CDR/TDR issued by any schedule bank in Pakistan.
- O6. All terms and conditions of procurement processes guidelines issued by the Works Secretariat vide Notification No.Sec-SO-D- 9(28)/2022-23/475 dated 26th January, 2023 and PEC bidding documents shall be part of procurement.
- 07. Rate quoted below 10% of the Technical Sanction shall be considered as unworkable, however. The bidder quoting rates below 10% of TS shall be required to provide along-with his bids an additional performance guarantee of 50% of the differential amount (between TS and bid) in shape of CDR from any schedule Bank.
- 08. In case of Gazette holiday/local holyday, tender shall be opened on next working day without further intimation.
- 09. Performance guarantee shall be @ 10% of the contract amount from any scheduled bank, in shape of CDR in favor of Employer valid for a period of 28 days beyond the bid validity date.
- 10. Bid shall be opened in the office of the Executive Engineer B&R Division C&WD Shigar.
- 11. The Contractor debarred by any Region/Division and notifies by Works Secretariat shall not be eligible to participate in the bidding process in all regions.

- 13. Power of Attorney for bidding should be in Rs.100/- stamp paper in original mentioning the project name with employer stamp.
