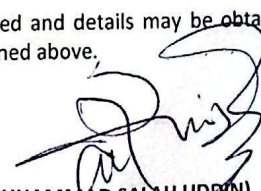

5. The rates of those items which are not included or covered after award of tender to successful bidders in the "Prescribed Form" will be determined in accordance with the prevailing market price at the time of supply/delivery.
6. All kind of taxes may be included in the bid price and shall be borne by the firm/dealers /suppliers/contractors.
7. Conditional, ambiguous & incomplete tenders shall not be accepted.
8. Experience in relevant field, registration certificate and non-blacklisting certificate must be attached with bidding documents.
