

01. Registration with Pakistan Engineering council in relevant Category/Code (EE-04 EE-05) duly renewed for the 2024-2025 (Mandatory)
02. Receipt of renewal fee for the year, 2024-2025 in W&P Department Gilgit Baltistan (Mandatory)
03. Contractor/Firm should provide difference amount in shape of extra call deposit in any schedule Bank of Pakistan, alongwith tender document, else tender will be rejected.
04. Tenders should be submitted in sealed envelopes indicating the name of contractors on the envelopes.
05. The bid Security 2% of earnest money cost of estimate in form of call deposit issued by a scheduled Bank of Pakistan in the name of Executive Engineer W&P Division Skardu valid for a period of 28 days beyond the bid validity period. No Bankers Cheque or pay order will be entertained.
06. Financial status of the firms/contractor of schedule Bank with a minimum balance of 80% of estimated cost (1st July 2024 to Bid opening date, duly verified by the bank Manger (in original), attached with bidding document (Mandatory)
07. Experience of similar nature of work (Mandatory).
08. Bid Security in shape of CDR from any scheduled bank / should be attached with the tender documents. Tenders without bid security will be summarily rejected.
09. The bidders may obtain the bidding documents by submitting a written application with copy of CNIC.
