MINUTES OF PRE-BID MEETING

Procurement of Biomedical Equipment

PSDP Project: Establishment of 250-Bedded Hospital, Skardu (Phase-I)

In order to ensure transparency and uniform interpretation of bidding documents, a Pre-Bid Meeting of the Procurement Committee was held regarding procurement of biomedical equipment for the above-mentioned PSDP project.

The meeting was held on 29th, 30th & 31st December, 2025 at GB House Islamabad under the chairmanship of the Chairman Procurement Committee, with participation of Committee Members and representatives of prospective bidders (Attendance Sheet attached). The consultant ESSIAAR attended the pre-bid meeting via zoom.

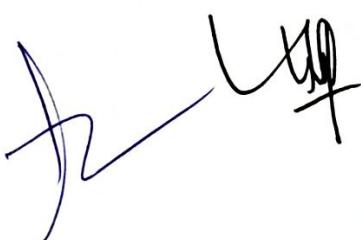
The purpose of the meeting was to clarify technical, financial, and procedural aspects of the bidding documents prior to submission of bids.

Queries raised by the prospective bidders were deliberated upon by the Procurement Committee and decisions were recorded as under, which shall form an integral part of the bidding documents.

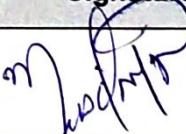
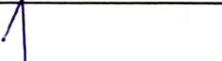
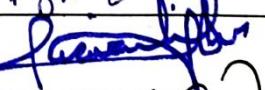
