Sealed tenders may be submitted to the undersigned on or before the date mentioned against each category before the closing date and time, which will be opened by the committee on above mentioned date and time in presence of the contractors/Suppliers or their authorized representatives at AC Office Gilgit, on closing date **18<sup>th</sup> July 2025, at 11:00 AM.**
2. Contractors/Suppliers may offer only the category of tender in which he has complete setup (Own shop/Store/Workshop) with documentary evidence.
3. The contractor/supplier must have adequate supply in Gilgit town and the firm will be bound to supply the demanded items/ services at Gilgit.
4. The bidding documents of only registered firms/dealers/suppliers/contractors shall be entertained.
5. Tender for each category must be offered by mentioning name of category in bold letters on sealed envelopes.
6. Single envelope containing technical and financial proposal to be submitted separately for tender of Misc items and office stationary.
7. The rates of items not covered in the "prescribed Form" will be determined in accordance with the prevalent retail price in the open market at the time of supply.
8. The bid security/call deposit (refundable) in the shape of bank draft/pay order by a schedule bank in the name of AC Gilgit, to be attached with the technical documents bidding/tender documents. No tender without call deposit from a schedule bank will be accepted.

Bank statement for last two year, five year work experience in relevant field, registration certificate CNIC of the owner, letter pad of firms with address vender number & Telephone number and Affidavit mentioning the firm not been black listed duly verified by Magistrate 1<sup>st</sup> Class must be

and/or mentioning the firm has been short listed by Magistrate & shall be attached with technical bidding documents. All contractors must fulfill the technical terms and conditions.
