Technical Proposals will be opened as per date mentioned above by Tender Committee while the "Financial Proposal" shall remain (in sealed form) in the custody of Assistant Commissioner Office Danyore and would be opened after receipt of technical evaluation report. The technically qualified bids would be accepted. The "Financial Proposals" of the bids found technically un-acceptable shall be returned un-opened to the bidders under rules.
2. Rates should be in Pak. Rupee. The bidder shall submit bid security/earnest money @5% in the shape of Pay Order/Bank Draft of any Scheduled Bank in favor of DDO/Assistant Commissioner Danyore. In case of public holiday due to any reason the date of receiving and opening of the tenders will be next working day.
