Tender form will be sold/ issued from the office of the Executive Engineer Water & Power Division Diamer- Chilas to those original manufacturer or authorized dealers of original manufacturer who have deposited/renewal/enlistment fee for the financial year 2024-25. Tender should be placed in the sealed cover according to " **Single stage two envelope**" (SSTE) bidding procedure indicating the name of bidders on the envelope.
2. Bid security in shape of deposit at call/bank guarantee from any schedule bank of Pakistan should be attached with technical proposal otherwise tender will be rejected.
3. A complete set of bidding documents may be purchased by an interested bidder on submission of written application and payment of a non- refundable fee mentioned in the shape of bank draft in the name of Executive Engineer W&P Division Diamer- Chilas.
4. Criteria for evaluation of technical proposal included in the bidding documents. Financial proposals of only technically responsive bidders would be opened. Bidders may obtain further information from the office of the undersigned during office hours.
5. Bidding documents will not be sold/issued on the day time of opening of tender.
6. The authorities of GB Water & Power department reserve the right to reject to any or all bids prior to the acceptance of bid or proposal under provision of rule -36 GB PPRA rule 2022 intimating the reason for rejection accordingly.
7. Payments will be made on availability and release of funds.
