01. Single stage two envelope bidding (Two separate envelopes marked as **Financial Proposal** and **Technical Proposal** in bold must be submitted.)
02. Tender will be opened by the committee on above mentioned date and time in presence of the contractors/suppliers or their authorized representatives at Governor's Secretariat Gilgit-Baltistan, Gilgit.
03. Contractors/Suppliers may offer only for that category of tender in which they have complete setup (Own Shop/Store/Work Shop) with all documentary evidence.
04. The bid security/call deposit (refundable) in shape of bank draft by a schedule bank in the name of **Secretary to Governor Gilgit-Baltistan** be attached with the technical documents. Tender without call deposit from a schedule bank will not be entertained.
05. The bidding documents of only registered firms/dealers/suppliers/contractors will be entertained.
06. The rates of items if not enlisted in the "Prescribed Form" will be determined in accordance with the prevailing retail price/market rate at the time of supply.
07. Following documents i). call deposit ii) firm registration certificate iii) 5 years relevant work experience in relevant field iv) 6 months latest Bank Statement v) Non Black Listed Affidavit **must be attached** with the technical bidding documents besides, CNIC of the owner, Letter Pad of Firm with complete address and Vendor Number.
08. Irrational/artificial and dubious rates offered by the firms/contractors will be rejected.
09. All kind of taxes applicable (if any) will be inclusive in the bid price and will be borne by the firms/dealers/suppliers/contractors.
