- The Technical Bid evaluation report prepared and signed by the procurement committee, approved by Deputy Director Water Management & Irrigation District Diamer as Chairman procurement committee and subsequently uploaded in PPRA web site vide PPRA Ref No. TSE-202506201295. 01 No's aggrieved bidder Namely "M/S Muhammad Mushtaq Brothers & Sons JV M/S. S Khalid & Brothers," approached/filed complaint to the PAO against the Technical Bid evaluation report. The competent authority constituted GRC vide above referred notification.

PROCEEDINGS:

"M/S Muhammad Mushtaq Brothers & Sons JV M/S. S Khalid & Brothers"

On the basis of the applicant reservations, the GRC has thoroughly examined the technical bid documents of the M/S Muhammad Mushtaq Brothers & Sons JV M/S. S Khalid & Brothers and observed the following facts and findings:

FACTS & FINDINGS:

1. General Experience:

The technical proposal of bidder was checked under the General Experience section NO. 3.2.2 (i) similar nature and found that the Lead Partner "M/S Muhammad Mushtaq Brothers & Sons" was given 12 marks by the tender committee out of total marks 45. During the course of examination, it reveals that work orders and completion certificate of similar nature work is attached hence 15 marks is given against 03 Nos projects and total marks is increased from 12 to 27.

2. Equipment Capabilities:

Under equipment capabilities section No 3.2.4 (i, ii, iii, iv, v, vi) Lead partner was given 0 marks by tender committee out of total marks 10. Whereas on examination of bidding documents, it has been observed that the contractor has attached list of equipment duly attested by the Excise and Taxation officer Motor Registering authority Gilgit at back side of the capabilities of machines/equipments list at page No 114 of technical bid and awarded 10 marks.

3. Financial Soundness:

Under Financial Soundness section 3.2.5 (i) lead partner was given 0 marks by the tender committee out of total 10 marks. While on examination of bidding documents it has been observed that the available credit line certificate is attached by the contractor so 10 marks is given and the **total marks is increased from 16 to 26.**

PROCEEDINGS:

"JV M/S. S Khalid & Brothers"

On the basis of the applicant reservations, the GRC has thoroughly examined the technical bid documents of the "JV M/S. S Khalid & Brothers" and observed the following facts and findings:

FACTS & FINDINGS:

1. Equipment Capabilities:

Under equipment capabilities section No 3.2.4 (i, ii, iii, iv, v, vi) Associate partner was given 0 marks by the bid opening committee out of total marks 10. Whereas on examination of bidding documents it has been observed that the contractor has attached list of equipment duly attested by the Excise and Taxation

officer Motor Registering authority Gilgit at back side of capability of machine/equipment list at page NO. 32 of technical bid and awarded 10 marks.

2. Financial Soundness:

In section 3.2.5 (i) lead partner was given 0 marks by the tender committee out of total 10. While on examination of bidding documents it has been observed that the available credit line certificate is attached by the contractor so 10 marks is given and the **total marks is increased from 16 to 26.**

(Note) All other criteria except mentioned above are correctly evaluated by tender committee.



FINDING

The lead partner is qualifying all set criteria whereas Associate partner disqualify sub category (General Experience) scoring 01 marks which is less than 40% of sub category, hence as per Section 3.3.1 (A) iv. As stated "The lead Partner score 55% marks in each sub category whereas the associates should get 40% mark in each sub category below this threshold it shall be considered nonresponsive"


RECOMMENDATIONS

1. As per re-evaluation of the GRC the bidder namely "JV M/S. S Khalid & Brothers" has failed to secure the minimum marks under the sub-category **General Experience**, as per Section 3.3.1 (A) iv. As stated "The lead Partner score 55% marks in each sub category whereas the associates should get 40% mark in each sub category below this threshold it shall be considered nonresponsive" hence the decision of tender evaluation committee is hereby up held for disqualifying the firm for further financial bid opening and other necessary proceedings.

The tender opening committee may proceed further necessary actions strictly as per PPRA rules.



On the basis of the applicant reservations, the GRC has thoroughly examined the technical bid documents of the **M/S SYED BUGHDAD & SONS CO. ALAM UD DIN GOVT. CONTRACTOR AND ARSHAD & BROTHER GOVT. CONTRACTOR** and observed the following facts and findings:

FACTS & FINDINGS:

1. Qualification Criteria

The technical proposal of bidder was checked under the mandatory condition (B) and found that the contractors namely "**M/S SYED BUGHDAD & SONS CO., ALAM UD DIN GOVT. CONTRACTOR AND ARSHAD & BROTHER GOVT. CONTRACTOR**" have provided photo copy of No Blacklisting and No Litigation Certificate.

FINDING

As per criteria mentioned in mandatory condition (B) the bidders have to provide No Blacklisting and No Litigation Certificate duly attested by 1st Class Magistrate or Oath Commissioner (**latest dated and Original**) while the bidders have provided photo copies of No Blacklisting and No Litigation Certificates instead of original and attested.

RECOMMENDATIONS

1. As per qualification criteria the bidders namely "M/S SYED BUGHDAD & SONS CO., ALAM UD DIN GOVT. CONTRACTOR AND ARSHAD & BROTHER GOVT. CONTRACTOR" have disqualified in mandatory conditions (B) (not producing of original no blacklisting and no litigation certificates) and not selected for further evaluation, hence the decision of tender evaluation committee is hereby up held for disqualifying the firm for further evaluation, financial bid opening and other necessary proceedings.


The tender opening committee may proceed further necessary actions strictly as per PPRA rules.

On the basis of the applicant reservations, the GRC has thoroughly examined the technical bid documents of the **M/S DM Builders Govt Contractor** and observed the following facts and findings:

FACTS & FINDINGS:

1. Qualification Criteria

The technical proposal of bidder was checked under the mandatory condition (B) and found that the contractor namely "**M/S DM Builders Govt Contractor**" has provided photo copy of No Blacklisting and No Litigation Certificate instead of (original and duly attested).

PROCEEDINGS:

"M/S Shan Builders and Construction"

On the basis of the applicant reservations, the GRC has thoroughly examined the technical bid documents of the "**M/S Shan Builders and Construction**" and observed the following facts and findings:





FACTS & FINDINGS:

All Documents provided by bidder in technical bid documents is correctly evaluated by tender opening committee hence the bidder ("**M/S Shan Builders and Construction**") failed to secure minimum marks in qualification criteria sub categories of section (3.2.2, 3.2.4 and 3.2.5).

PROCEEDINGS:

"M/S Shahbaz and Sons"

On the basis of the applicant reservations, the GRC has thoroughly examined the technical bid documents of the "**M/S Shahbaz and Sons**" and observed the following facts and findings:

1. General Experience:

The technical proposal of bidder was checked under the General Experience section NO. 3.2.2 (ii) (*similar nature work in hand*) found that the contractor "**M/S Shahbaz and Sons**" was given 2.5 marks by the tender committee out of total marks 10. During the course of examination, it reveals that work orders and Performance certificate of 02 Nos similar nature work in hand is attached so 05 marks is given against 02 Nos projects and total marks is increased from 2.5 to 5.

Section NO. 3.2.2 (iii) (*non-similar nature work*) found that the contractor "**M/S Shahbaz and Sons**" was given 7.5 marks by the tender committee out of total marks 10. During the course of examination, it reveals that work orders and completion certificate of non-similar nature work is attached so 10 marks is given against 04 Nos projects and total marks is increased from 7.5 to 10.

(Note) All other criteria except mentioned above are correctly evaluated by tender committee of all applicants.

FINDING

As per criteria mentioned in mandatory condition (B) the bidder (**M/S DM Builders Govt Contractor**) has to provide No Blacklisting and No Litigation Certificate duly attested by 1st Class Magistrate or Oath Commissioner (**latest dated and Original**) while the bidder has provided photo copies of No Blacklisting and No Litigation Certificates and disqualified for further evaluation.

The bidder "**M/S Shan Builders and Construction**" failed to secure minimum passing criteria in each sub category and over all criteria and disqualified as per note

given in Section 3.2.1 (The applicant must secure at least 55% score in each category and an overall 60%)

The bidder "**M/S Shahbaz and Sons**" failed to secure minimum passing criteria under section 3.2.2 General Experience and disqualified as per note given in section 3.2.1 (The applicant must secure at least 55% score in each category and an overall 60%)

RECOMMENDATIONS

1. As per re-evaluation of the GRC, the bidders namely "**M/S DM Builders Govt Contractor, M/S Shan Builders and Construction and M/S Shahbaz and Sons**" have failed to secure the minimum marks and qualifying criteria based on details mentioned in **finding**, hence the decision of tender evaluation committee is hereby up held for disqualifying the firms for further financial bid opening and other necessary proceedings.


The tender opening committee may proceed further necessary actions strictly as per PPRA rules.
