- Late submission of bid will not be entertained.
- NOC of No Sick project & No litigation certificate from office of the Chief Engineer of any region.

#### **TERMS & CONDITIONS:**

1. The bid security of Engineers cost estimate in form of Call Deposit(which will be verified from concern bank if deem necessary issued by a schedule bank of Pakistan in the name of Executive Engineer B&R Division GB C&WD Diamer.
2. Conditional tender shall not be accepted.
3. In case of firm/company joint venture registered power of attorney and partnership deed in original must be produced for issuance of tender documents JV agreement, proper format PCE duly signed by all partners of JV clearly mentioning share of each partner lead and associate partner duly attested by Magistrate 1<sup>st</sup> Class shall be mandatory.
4. In Case of any local holiday tender will be opened next working day at same time & venue.
5. Rates quoted below 10% of T/S shall be considered as unworkable however,
  - a. The bidder quoted rates below 10% of TS shall be required to provide along with his bid an additional 50% of the differential amount (between T/S & Bid) cost. In shape of CDR Guarantee from any schedule bank. CDR from KCBL shall be rejected.
  - b. In case of failure to produces the required differential amount of the bid by the bidder along with his bid documents, the bid shall be rejected.
6. The revised tender policy issued vides Communication & Work Department secretariat vide notification No. Sec-SO-D-9(28) /2022-23/475 dated 13<sup>th</sup> January, 2023 and PEC bidding documents will be followed.
7. Bids shall be opened in the office of the Executive Engineer B&R Diamer Chilas. Mentioned date and time, late receipt of bid shall not be entertained.
