A complete set of bidding documents may be obtain by any interested and eligible bidder on submission of written application a non-refundable fee mentioned above against each work. The bidders acquire the bidding document from the office of the Executive Engineer LG&RD Ghanche during the office hours.

1. Valid license of Pakistan Engineering Council renewed up to 30th June 2025 in relevant category code and field of specializations.
2. A complete set of bidding documents containing detailed terms and conditions may be purchased by an interested eligible bidder on submission of a written application on original letter head on production of bid security (3%) and original CNIC from the office of the undersigned.
3. In accordance with GB.PPRA rule-2022, Bid Security as indicated is required in the shape of CDR, Bank Draft or Bank Guarantee in favor of the undersigned by any scheduled bank in Pakistan, dully mentioned the name of work and title of the firm otherwise clearly rejected.
4. Conditional/incomplete and lump sum bid will be straightly rejected.
5. No bidding document will be issued through post, telegraph or e-mail and on the day of opening the undersigned in accordance with PPRA rule-36 of 20221 may reject all bids or proposals any time prior to acceptance of a bid or proposals.

8. Renewal fee slip of GB-PWD for the current financial year 2024-25 & Bank statement dully showing the balance amount at least 50% of the estimated cost(Aug to bid opening date) of the project dully verified by Bank authority in original otherwise bid will be rejected.
